



COVID-19 Reopening Facility Guidelines & Procedures

Active Adult Life Center

As of June 28, 2021, per the Pennsylvania Department of Aging and Philadelphia Corporation of Aging, COVID-19 mitigation strategies for Senior Community Centers will be lifted, with guidance from Centers for Disease Control and Prevention and Pennsylvania Department of Health. This guidance shall not prevent KleinLife from continuing and/or implementing stricter mitigation efforts based on arising circumstances on site.

Per the Pennsylvania Department of Aging, senior centers, including KleinLife, cannot require participants, staff, or volunteers to be vaccinated to attend or participate in center activities. KleinLife also may not request proof of vaccination, nor deny services to individuals who are not vaccinated or refuse to disclose their vaccination status. However, KleinLife may ask for the voluntary disclosure of vaccination status.

KleinLife has put in place preventative measures to reduce the spread of COVID-19; however, KleinLife cannot guarantee that you will not become infected with COVID-19.

Until vaccination rates increase and more is known about the length of vaccine protection and the effectiveness of the vaccines against emerging variants, it will be necessary to continue with some preventative measures.

Based on the strong recommendation of the Pennsylvania Department of Aging, the following guidelines will be used:

- Require all participants, staff, and volunteers to wear face coverings, regardless of vaccination status
- Printed COVID-related policies and procedures will be available to all participants
- All participants, staff, and volunteers will be notified of any necessary operational changes related to COVID-19
- Post signage in the center to:
 - provide educational information relating to COVID-19 and vaccines
 - remind participants, staff, and volunteers to stay home if they are ill
 - reinforce the wearing of face coverings
 - encourage frequent hand washing
- Utilize a reservation system program (to reserve, call 215-698-7300 x0 for an exercise program, x155 for a Russian Speaking program, or x193 all other programs)
- Continue Grab & Go meals as an alternative to congregate meals
- Continue the use of virtual programming as scheduling allows

By signing this document, I attest that I have read and agree to abide by these guidelines; I **voluntarily assume the risk that I may be exposed to or infected by COVID-19 by participation; and that such exposure or infection may result in personal injury, illness, permanent disability, and death.** I understand that the risk of becoming exposed to or infected by COVID-19 at KleinLife may result from the actions, omissions, or negligence of myself and others, including, but not limited to, KleinLife’s employees, volunteers, and program participants and their families. **I voluntarily agree to assume all of the foregoing risks and accept sole responsibility for any injury to myself (including, but not limited to, personal injury, disability, and death), illness, damage, loss, claim, liability, or expense, of any kind, that I may experience or incur in connection with my participation at KleinLife.** I understand and agree that this release includes any Claims based on the actions, omissions, or negligence of KleinLife, its employees, agents, and representatives, whether a COVID-19 infection occurs before, during, or after participation at KleinLife.
